WSIB Rate Framework Update

Reminder: WSIB hosting technical rate sessions on 2017 premium rates



As the *Workplace Safety and Insurance Board (WSIB)* announced several weeks ago, in 2017, there will be a **five per cent reduction on the average premium rate for Schedule 1**. This is the first overall premium rate reduction since 2001.

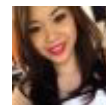

Workplace-based resistance training can help prevent upper extremity MSDs

Allowing workers to do resistance training on the job is a recommended way for workplaces to help prevent and manage upper extremity musculoskeletal disorders (MSDs). That is one of the key findings of a systematic review conducted by the *Institute for Work & Health* and being highlighted to mark **Global Ergonomics Month**. Resistance training refers to exercises that cause the muscles to contract against an external resistance (e.g. dumbbells, rubber exercise tubing, own body weight, etc.) with the expectation of increases in muscle strength, tone, mass and/or endurance. Based on the review's findings, workplaces should also consider implementing stretching exercise programs (including yoga), workstation forearm supports and vibration feedback on mouse use, if applicable to the work context. 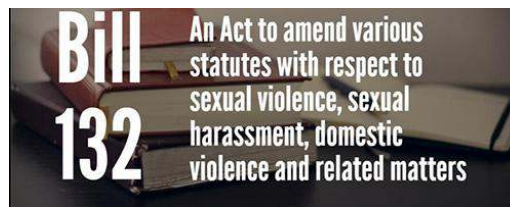

Working at Heights - Student Rate

To make the largest impact on future injuries due to working at heights, concentrating on reaching our young workers and providing them with quality training is imperative.



In response to the need and as an investment in our future workers, PSHSA is supporting School Boards across the province in their efforts to train students enrolled in the *Specialist High Skills Major (SHSM)* program to the new *Working at Heights (WAH) Standard* by providing **Blended WAHs Training** at a reduced student rate.

Working with a number of School Board and Schools, PSHSA is scheduled to train over 70 students this semester.

Prevention of Workplace Violence - Discovery Workshop

PSHSA is in the planning stages of developing a resource focused on supporting workplace violence and serious student incidents, specific to the school community. We will be hosting a discovery workshop to explore this concept in greater depth.

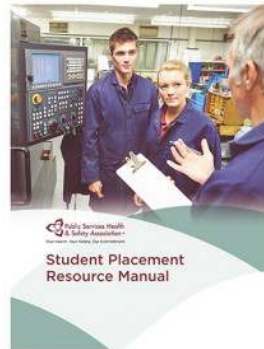

Regional Training Site Update

Following the early 2016 announcement that PSHSA and the Ontario Association of Fire Chiefs (OAFC) have partnered to provide improved training access, centralized services and revised high hazard curriculum for the fire service in Ontario.



A walkthrough of the newly developed Chapter 5 training was held at OAFC offices in Ajax on September 29. The launch of the program will be hosted by Kitchener Fire Department from October 17-20, 2016 with a class of 12.

Official Launch of Health and Safety for Building Inspectors

PSHSA Fire Training Reminder For Vulnerable Care Occupancies

Up until December 31, 2016, the OFMEM will cover the course fee for one owner/operator per facility housing occupancy. For others, the cost is \$125.00 pp for online learning, and \$150.00 pp for traditional classroom. A passing grade of 70% on the test found at the end of the course is required to receive a certificate of completion and it is possible to retake the test an unlimited number of times.

Over the last 25 years, there have been a number of significant fires in occupancies housing vulnerable persons. The inquest into the fatal fire at the Muskoka Heights Retirement Residence in Orillia issued 39 recommendations in 2012. Many people within these facilities have special needs and those that require assistance with evacuation are more vulnerable during fire emergencies.

As a result of these learnings there is new legislation governing compliance including the implementation and approval of fire safety plans in vulnerable occupancies. The new Fire Code legislation requires that the person responsible for implementing the *Fire Safety Plan for a Care Occupancy*, complete an Office of the Fire Marshal approved course. Vulnerable occupancies include:

- Hospitals,
- Long Term Care Homes (previously called Nursing Homes or Homes for the Aged),
- Retirement Homes regulated under the Retirement Homes Act, 2010,

- Group Homes, and,
- Care Occupancies.

PSHSA is the only approved training provider offering this **qualification course**. The course can be taken through an eLearning module OR as an in class training option.

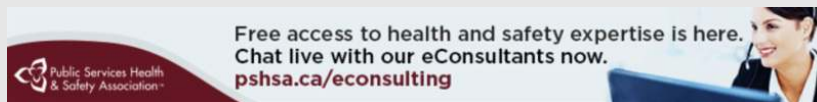
