4. Outline methods for controlling them.

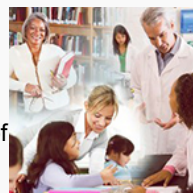

Health and Safety for Supervisors and Managers

The program enhances a participants' knowledge of legislated health and safety responsibilities, the internal responsibility system, worker's rights and the supervisor's role in workplace management.



Upon completion of this program, participants will have met the requirements of section 27 of the Act in relation to supervisor/manager competency. This program is designed for all supervisors and managers and is applicable across all sectors.

Training the **Fit Tester** for Respiratory Protection

Participants will learn about the legislation, knowledge and skills required to conduct their own qualitative fit testing (QLFT) as outlined by the CSA Standard Z94.4-11.



This 1/2 day course will train participants on the requirements within a respiratory protection program and qualify them to educate and prepare workers for the fit test.
